# A SOPHISTICATED, TARGETED SCAM

Savvy criminals target lawyers like Kolette Kresses-Piasecki. This phishing email imitated messages she and other professionals receive daily. Unfortunately, the wrong response unwittingly gave hackers control of her email.

Operating in the background, they sought to trick the firm's clients into wiring money to overseas bank accounts. To her, nothing appeared unusual. She then contacted each person who received a spam message and confidently informed them the threat was over.
